Your consent applies only to the receipt of statements, disclosures, notices and other communications related to these account(s). You may discontinue electronic delivery and resume receipt of paper documents by sending us an email request. Computer Requirements: To protect your personal and account information, we ask that you have: A Windows-or Macintosh-compatible computer, A printer, or sufficient disk space to save copies of your documents, Internet access and a browser that meets these requirements: For PC using Windows 95,98,NT,2000,ME,XP: Microsoft Internet Explorer 5.5 or higher, Microsoft Internet Explorer with AOL 5.5 or higher, Netscape 6.2 and higher, For Macintosh using OS9 and OS 10: Microsoft Internet Explorer 5.0 or higher, Microsoft Internet Explorer with AOL 5.0 and higher, Netscape 6.2 and higher, Safari 1.0 or higher (for OS 10 only).

Once this document is completed, we will e-mail you and asked that you reply as to whether you were successful at retrieving your requested bank statement electronically.
